





District 1: 14 responses




District 2: 8 responses

District 3: 11 responses





District 5: 37 responses




District 6: 13 responses







Evaluate Form Q2, Expectations


Evaluate Form Q3: Importance of Implementing the Framework Recommendations: 113 total responses

Average Importance rating of 4.3




District 2:Average Importance






District 5:







District 1: 14 Responses




District 2: 6 Responses



District 3: 11 Responses




District 4: 18 Responses



District 5: 37 Responses





Respondents generally expected to hear about connections and resources to help improve neighborhoods.


- One respondent expected specific information on a blighted house in their community
- One respondent expected the break-out sessions to be structured as open forums
- One respondent stated that the event exceeded their expectations for content and resources provided
- One respondent stated that they did not know what to expect, since the descriptions of the break-out sessions were minimal.

Evaluate Form Q2, Suggested Improvements: 7 Responses


- 3 respondents criticized the structure of the break-out sessions, commenting that they would have preferred to be able to attend more sessions
- 1 respondent suggested having more events like Blight Boot Camp, either with youth or community involvement

- 1 request for a workshop on or breakdown of the DFC Strategic Framework
- 1 respondent wanted more practical or tangible takeaways from the event



Evaluate Form Q7, General Comments: 10 responses

- 7 respondents gave general positive feedback on the event
 - 5 respondents reported satisfaction with the quality of the event, as well as the networking opportunities and information given
 - 2 respondents complimented the food
- 4 respondents made suggestions or critiques
 - 1 request for shorter twitter hashtags for future events
 - 1 request for a list of the contact information of presenters
 - 1 request that the DFC continue doing PR work and reaching out
 - 1 respondent commented that the breakout session descriptions should have been provided ahead of time


Evaluate Form Q2, Suggested Improvements: 7 responses


Evaluate Form Q3, Importance of Implementing the Framework Recommendations: 23 responses

- 5 requests for more demolitions and blight removal efforts
- Wayne Metro expresses specific interest in partnering on minor home repair projects, blight demolitions and rehabilitation
- 1 request for more lights, street signage, and enforcement of regulations on buildings, storefronts and autoshops
- 1 request for continued cleanup as well as removal of squatters from housing
- 1 request for increased emphasis community education on protecting health during demolition

Beautification: 6 responses

- 2 requests for more urban gardening and community gardening
- 1 suggestion for increased beautification efforts around Roxbury Street and Whittier areas
- 1 suggestion to develop Rouge River on Ridge Road as a nature area, stop dumping, clean area of trash, board up all vacant homes and keep up signage to discourage blight
